

Conditions of Hire:

- Black Prince Trust reserves the right to terminate any hire agreement at any stage.
- Any property and/or vehicles left on the premises are done so at the owner's risk.
- Black Prince Trust accepts no responsibility for injuries or accidents to participants during their sessions.
- There is a strict no filming policy. If you wish to film in one of the facilities, you will need to BPT's permission to do so. Please contact Lou@blackprincetrust.org.uk for any filming enquiries.
- Users must only wear suitable trainers in the sports hall ie astroturfs, heels, school shoes etc are not permitted to be worn inside the facilities at any time.
- Users are responsible for leaving all facilities used, including changing areas and toilets, in a clean and tidy condition.
- No food or drink is to be consumed within the hired areas. Any additional cleaning costs incurred will be charged to the user(s).
- Avoidable damage caused to the lights, fire alarms, smoke fittings, window protectors etc. to the facilities, and any other equipment during any session, will be charged to the person/group named on the booking form.
- Users are not allowed to use any vinyl's, stickers or banners to walls or the floor without BPT's permission. If the trust approves, BPT have the right to charge deposit in case damage is caused.
- Please report damage caused to any of the facilities as soon as possible, either to the Lou@blackprincetrust.org.uk or call 0207 840 2904 as soon as possible.
- Users are only authorised to use the equipment and facilities they have booked. This will be specified during the initial hire agreement.
- Hire slots must not over-run due to late starts.
- Black Prince Trust will notify the user(s) of unfit playing conditions, giving at least 24 hours notice (where possible) of cancellation. No fee will be owed if cancellations are as a result of bad weather or necessity by the Trust.
- Cancellations incurred less than 48 hours before the proposed date of hire will result in a charge being levied for the full hire cost of the facilities.
- Please respect the local residents by keeping the noise to a minimum when in the carpark and leaving the premises.
- **Fire action notices are located on site. In the event of a fire/fire alarm, please leave immediately through the clearly displayed fire exits and make your way to the assembly point in the car park. If fire is in the car park or obstructing your access, please wait safely on the surrounding residential grounds until a BPT member of staff has seen you.**

Please make all of your club members, participants and opposition members aware that Black Prince Trust is on a residential site where speed limits apply. Please drive sensibly and cautiously at all time.

Users of Black Prince Trust must abide by the Covid19 guidelines set out by the Trust at all times. On arrival please wash your hands and use the provided hand sanitiser when possible to do so.

BPT COVID-19 WAIVER

 - E. are following all Government recommended guidelines as much as possible and limiting exposure to the Coronavirus/Covid-19

I hereby release and agree to hold the Black Prince Trust harmless from, and waive on behalf of myself, members of the group, and any personal representatives and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by any act, failure to act of the Trust, or that may otherwise arise in any way in connection with use of the Trust facilities.
